The template has been updated slightly for Academic Affairs Units (added sections for core, major, and graduate assessment). The IERs/IEPs are due on Sunday, September 30, 2012.

A copy of the suggested rubric and SMART goals presentation was also distributed. An email will be sent to committee members once the IEP and IER documents become available.
